If you have accepted, or are going to accept, our offer there are a number of preparatory activities we would like you to complete over the summer. PREPARING FOR ORIENTATION WEEK

The University and School's programme of induction will commence on Monday 5th September. Orientation week comprises 5 full days of University and course activity to which all students are expected to be present in St Andrews for.

The first session will likely be held in person in the School Booth Lecture Theatre on Monday 5th September 2022 at 9.00am. Due to the practical nature of the medical course, students cannot study remotely.

Students will find it essential to have access to a laptop or mobile device to enable them to engage flexibly with teaching and supplementary learning resources as required throughout their studies.

Covid-19 Placements in the clinical environment

Students in year 1 of the course normally have one day of clinical placement during Semester 2. For academic year 2022/23 it is not known at this stage whether this will be a face to face placement or a clinically orientated virtual placement. As you progress into years 2 and 3 of the course you will need to be in St Andrews to complete the clinical placement requirements of the programme, which will undertake a variety of delivery formats. It is not possible for students to meet the requirements set out in the GMC's Outcomes for Graduates without undertaking clinical placements. Covid-19 students at increased risk

Most medical students fall into a low risk category in terms of experiencing severe illness from Covid-19. Medical Schools also recognise that they owe you a duty of care. Occupational Health will discuss underlying health issues pre-placement. There will be some students who are concerned due to their underlying health conditions, vulnerable dependents or increased caring responsibilities. If you are concerned and wish to discuss please email medsupport@st-andrews.ac.uk to arrange a time to talk on Teams.

<u>Immunisations</u>: If you can organise the requisite immunisations before starting the course that would be helpful. Guidance is that all healthcare workers with patient contact should provide evidence to show immunity to Pertussis (whooping cough), TB, Measles, Rubella (german measles), Varicella (chicken pox) and Hepatitis B. *In addition, Covid-19 immunisation is strongly encouraged.* Please remember to take copies of any documentation related to your past vaccination. If you have missed any scheduled immunisations and your situation allows please catch up with these.

HEALTH

The personal health of a medical student is important for a range of reasons:-

a. Students must be fit to enter the course; be able to participate in the rigorous academic and practical programme and live independent lives.

- b. Students must be fit to study; able to learn, revise and sit exams.
- c. Students must be fit for practice; they should not pose a risk to patients nor be at risk from patients.
- d. Students must be fit to practise, that is they are likely to be fit to be registered as a doctor by the General Medical Council. To be registrable they must pose no risk to patients and must not damage the reputation of the medical profession.

HEOPS standards. The School of Medicine uses the standards defined by the Higher Education Occupational Health Physicians (HEOPS) to decide if a student is Fit to Enter the course. All applicants must read the <u>School's advice</u>, the HEOPS standards and complete the certificate by 3rd August. If you have any queries about this declaration, these can be emailed to medsupport@st-andrews.ac.uk prior to signing the form.

Occupational Health questionnaire. All applicants must complete and return the Occupational Health Questionnaire which will be sent to you by separate email. Please read the covering letter which contains all the relevant advice and instructions and send it back by the end of July. Please do not return the form if you have declined, or intend to decline our offer.
